Neshaminy Interplex: Thank you Mike, Denise and Erin for taking the time to speak with us. Your firm has been a fixture at the Interplex for more than 13 years and we're certain people would like to hear your story in greater detail. Can you take us back to the early days of **Rudolph Clarke**?

Denise Smalley: Of course. Our firm has been in existence since 2001. We started out in a smaller office not too far from the Neshaminy Interplex. We set out to serve the community in both municipal law and also general practices, like personal injury, wills, estates and other transactions.

Michael Barbiero: Although we have a strong concentration in municipal and local governmental representation, our attorneys are dedicated to serving every member of the community. Each client gets our very best effort, whether we are helping a township adopt an ordinance or a family coping with a catastrophic injury. Our attorneys achieve tremendous results.

NI: When you say local, what is your area of focus?

Erin Barone: For municipal work, we are focused primarily on Bucks and Montgomery County, but we really represent people from all areas, including Chester and Delaware County and Philadelphia. The general practice area has grown significantly since our early days.

NI: Is that why you selected the Neshaminy Interplex location?

Denise: Exactly. We loved the location as soon as we saw it. The proximity to our clients is great. Also, the amenities here at

the Interplex are like nowhere else.

NI: You weren't always here in Building Seven.

Denise: No, we started with 1,600 square feet in Building Four in 2002. Back then there were just 2 attorneys and 2 staffers.

Mike: Around 2003 we nearly doubled our space. Then, five years later, we found our way over to Building Eight for another needed expansion. That gave us about 4,100 square feet.

Denise: Right. But last year we felt we were again bursting at the seams, so we took this larger space here in Building Seven (approximately 5,800 square feet) to better accommodate the 14 attorneys and 7 staff members.

NI: Glad we could serve your needs each time.

Erin: The Interplex has always been a good partner to us.

Denise: Our staff loves the views from this location, and we're so close to the fountain courtyard. We're also right across from the gym, which is popular, and we often use the conference rooms in Building Eight.

Erin: Don't forget, it's just a short walk to the Wawa!
